

Housewarming Party - CONTEST RULES

OFFICIAL PROMOTION RULES. 1. **No purchase is necessary / Membership is not required to participate in the prize drawing** 2. Eligibility for Promotion: Automatic entries: All TopMark Federal Credit Union ("Credit Union") Members in good standing who purchase a home using our financing during the period beginning November 1, 2019, and ending January 31, 2020. The Promotion period begins on November 1, 2019, and ends on January 31, 2020. Employees and volunteers of the Credit Union and their household members are not eligible. All winners will be notified by the Credit Union. If any prize is unclaimed, an alternate winner will be chosen. 3. Prizes. The Credit Union will award a total of One (1) prize consisting of the following: Purchasing food for a housewarming party up to but not exceeding \$350.00. 4. Automatic entry and eligibility for this prize promotion is based upon: purchasing a home and financing it with the Credit Union between November 1, 2019 and January 31, 2020.
